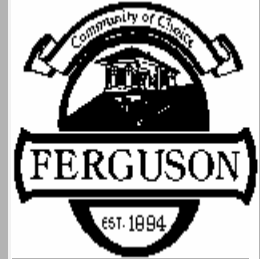


**FERGUSON CITY COUNCIL**

**Regular Council Meeting, October 12, 2004**

On October 12, 2004 at 6:30 p.m. the Council entered into closed session in accordance with RSMo 610.021 to discuss matters relating to litigation, legal actions, and/or communication from the City Attorneys as provided under Section 610.021(1) RSMo, and/or personnel matters under Section 610.021 (13) RSMo, and/or employee matters under Section 610.021(3) RSMo, and/or real estate matters under Section 610.021(2) RSMo.

A motion was made by Mayor Wegert and seconded to enter into closed session under Section 610.021 (3) (13) RSMo. The motion passed unanimously by roll call vote.

Under Section 610.021(3) (13) RSMo, employee/personnel matters were discussed.

There being no further business to discuss, a motion was made by Mayor Wegert, seconded, to convene to open session. The motion passed unanimously by roll call vote.

The regular meeting of the Ferguson City Council was called to order at 8:00 p.m. on October 12, 2004, by Mayor Steven Wegert, in the Council Chambers of City Hall, 110 Church Street, Ferguson, Missouri. Mayor Wegert requested that everyone stand for a moment of silent prayer, after which the Pledge of Allegiance was recited. On roll call the following Council members were present:

Mayor Wegert welcomed all present and explained the meeting would be the Public Portion and the Business Portion.

## **PUBLIC COMMENTS**

Mr. Watson – 821 Carson Road – had concerns and comments regarding the November 2, 2004 Propositions; current City projects; and water which is deteriorating his backyard. City Manager, A.J. Krieger, responded to his comments with some possible solutions. Discussion ensued.

Blue Tapp Scheffer – 705 N. Florissant Road – updates on Propositions 1 & 2, announced that there will be a televised meeting on Wednesday, October 13, 2004 and City Manager, A.J. Krieger will be speaking on the Propositions. Announced there will be a second Town Hall Meeting on Thursday, October 28, 2004 at Our Lady of Guadalupe Parish Hall, 1115 S. Florissant Road. ## **BILLS REQUIRING FIRST READING**

BILL NO. **6701** AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF FERGUSON, MISSOURI, ON BEHALF OF THE CITY TO ACCEPT FOR CITY DEVELOPMENT AND BEAUTIFICATION, REAL PROPERTY IDENTIFIED AS LOCATOR NUMBERS 12H410316; 12J310860; 12J310824; 12J310815; 13H632274; 13H630184; AND 13H632186, HELD IN TRUST BY THE TRUSTEE OF ST. LOUIS COUNTY. A FEE OF \$27.00 (TWENTY SEVEN DOLLARS) PER PROPERTY TO COVER THE RECORDING OF THE DEED IS REQUIRED; EFFECTIVE WHEN, introduced by Council as a Whole and read the first time.

## **WORK SESSION ITEMS**

City Manager, A.J. Krieger explained the items on the Work Session discussion.

President of the Gannon Development Company, Roland Burke; Executive Vice-President Dave Weygandt; and Vice-President of Construction, Bruce Studer made a presentation to Council regarding its plans to renovate the Park Ridge Apartments. A lengthy discussion ensued. Gannon is seeking a letter of support from the City for its application to the St. Louis County Housing Authority for low-income housing tax credits and bond financing.

Mr. Krieger – handed out a draft CIP incorporating the format/methodology changes discussed during the 9/28/04 Work Session for Council's review. Due to the City's cash flow constraints and the pending sales tax legislation on the November 2, 2004 ballot, Mr. Krieger would like Council to identify those individual project requests that they feel are priorities, specifically 05/06 fiscal year. The final document will be drafted based on this review to fulfill the Charter requirement of November 1. A lengthy discussion ensued. The detailed document will follow within a few weeks.

## **MISCELLANEOUS**

Mr. Kallstrom – Go Cardinals!

Mr. Crinnion – thanked Mr. Krieger for providing the Proposition 1 & 2 revenue projections. He then requested more specific information (dollar values) regarding the sales tax projections and allocation from Mr. Krieger. Mr. Krieger explained he would try to give some dollar amounts. Mr. Crinnion requested an update on the Pension Board's proposed changes and the Compensation Study. Mr. Krieger advised the study is near

completion but due to the City's financial position, not at a point to implement any of the items. It was discussed during the 04/05 Budget, there was turnover in the PAR Group, the firm responsible for the class/compensation study, which delayed it. Staff has a draft of the report, but is absent any kind of reasonable way to talk about implementation, until the sales tax is resolved.

Mrs. Faul – Go Cardinals! Suggested since this year's Boards & Commissions Dinner is cancelled, invite Board members to a Council Meeting in December to distribute their City pins and keys.

Mr. Krieger – Attended meetings and updated Council on the Airport Redevelopment Project Proposals. Updated Council on the Bid Specifications for the printing & mailing of the Proposition 1 & 2 Brochure. Upon Council's approval, the committee will mail out the brochures. The money for the mailing will be taken out of the *Community Relations* line item under the City Manager's Budget. Mr. Krieger requested the November 9, 2004 Council Meeting be re-scheduled for November 16, 2004 and hold one meeting in November. Council approved unanimously.

Mayor Wegert – Requested City Manager, A.J. Krieger provide statistics (numbers) from the Planning Department on projections on households in the Kemp area.

There being no further business to consider, the meeting adjourned at 9:30 p.m.
