Know Your Fair Housing Rights

The Missouri Commission on Human Rights is a governmental agency which enforces the state law that prohibits discrimination in Missouri's places of employment, public accommodations, and housing.

Discrimination under the Missouri Human Rights Act is based on the protected categories of race, color, religion, sex, national origin, physical or mental disabilities, age, and/or familial status.

All Missouri citizens have the right to access the housing of their choice. Apartments, houses, mobile homes, and even vacant lots to be used for housing are covered by the Missouri Human Rights Act. Anyone who has control over residential property and real estate financing must obey state and federal fair housing laws, including landlords, rental managers, property owners, real estate agents, bankers, developers, builders, and individual homeowners who are selling or renting property.

Under state and federal fair housing laws, it is illegal to commit the following acts because of a person's membership in or association with a person in a protected category:

- Refuse to sell or rent housing
- Lie about the availability of housing
- Evict
- Treat a tenant differently in the terms or conditions of housing, such as rent, security deposit, or maintenance
- Refuse to allow reasonable modifications necessary for the use of a dwelling by a person with a disability (at the tenant's expense)
- Fail to make reasonable accommodations in rules, policies, practices, or services necessary for a person with a disability to occupy the housing
- Set different home sale prices or impose different interest rates, points, or fees on a loan
- Reject a mortgage loan

Mission

This contest is open to all youths in grades K-12. To enter, students must write an essay or design a poster around the theme "Fair Housing Is Your Right. USE IT." Students must incorporate this theme in their essays or posters. The essay or poster should depict what it means for Ferguson residents to have the right to non-discriminatory housing – housing that is accessible and open to everyone, regardless of race, color, religion, national origin, ancestry, sex, disability, or familial status.

Prizes will be awarded to the 1st, 2nd, and 3rd place entries in EACH group as follows:

1st Place \$100

2nd Place \$50

3rd Place \$25

Poster Contest Age Groups:

Group 1: Kindergarten - Third Grade

Group 2: Fourth - Sixth Grade

Group 3: Seventh - Twelfth Grade

Journalism Contest Age Group:

Group 4: Seventh - Twelfth Grade

Poster Contest Rules

1. Paintings, drawings, photography, collages, or any other two-dimensional medium or combination of media in color or black-and-white is acceptable.
2. The words of the theme ("Fair Housing Is Your Right. USE IT.") MUST appear somewhere on the poster. **Posters without the words of the theme will be disqualified.**
3. Posters should be original and no larger than 11" x 17". Computer-generated art is acceptable, but the use of copyrighted photos or images is discouraged.

Journalism Contest Rules

1. All essays must be typewritten, double-spaced on white 8 1/2" x 11" paper and not exceed three pages.
2. The essay MUST include the theme ("Fair Housing Is Your Right. USE IT.") in more than just the title. The theme should also be incorporated into the body of the essay.
3. Each essay must identify all quotes, either within the body of the essay or as a footnote or endnote.
