COURT ORDER

VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES
EFFECTIVE FEBRUARY 1, 2021

Pursuant to 479.050, RSMo, Supreme Court Rule 37.49, the undersigned Municipal Judge of the City of Ferguson hereby orders that the following designated offenses shall be payable to the City of Ferguson Violations Bureau. In such cases, no court appearance is necessary.

This schedule is divided into four parts. Part I consists of the St. Louis County Municipal Court Uniform Traffic Violation Schedule, for moving violations (points). Part II consists of the St. Louis County Municipal Court Uniform Traffic Violation Schedule for non-moving violations. Part III consists of the City of Ferguson Violation Schedule for moving and non-moving violations which are not part of the Uniform Traffic Violation Schedule. Part IV consists of non-traffic ordinance violations which can be paid out of court as imposed by the City of Ferguson.

Court Costs

In accordance with Missouri statutes and ordinances adopted by the City. Court costs shall be paid in addition to the fine.

For cases issued BEFORE February 1, 2021, total Court Costs shall be \$26.50. This includes Basic Court Costs of \$12.00, Crime Victim's Compensation Surcharge of \$7.50, Law Enforcement Training Fund of \$1.00, Peace Officer's Standard Training Fund of \$2.00, Domestic Shelter Fund of \$2.00 and Biometric Verification System Surcharge of \$2.00; for a total of \$26.50.

For cases issued ON OR AFTER February 1, 2021, total Court Costs shall be \$33.50. This includes Basic Court Costs of \$12.00, Crime Victim's Compensation Surcharge of \$7.50, Law Enforcement Training Fund of \$1.00, Peace Officer's Standard Training Fund of \$2.00, Domestic Shelter Fund of \$2.00, Biometric Verification System Surcharge of \$2.00 and Show Me Court Automation Surcharge of \$7.00; for a total of \$33.50.


