CALL TO ORDER

There was no followup from FPD in regards to the FCRB reviewing redacted citizen complaints for the purpose of data collection for trend analysis.

The board has been able to complete its review of videos on complaint 21-001 and have begun discussion of the complaint. However, the discipline files are not available.

Ms. Kidd completed her training on Implicit Bias. Ms. Barton confirmed that Ms. Kidd has completed all required training.

The board has not received any word from NACOLE about the determination of scholarship awards for the annual conference. Ms. Barton will followup with NACOLE.

NEW BUSINESS

No new business was taken up by the board.

MISCELLANEOUS

Mr. Franks mentioned the need for an additional board member. Ms. Barton reported that she does have the name of a potential member for the board.
