About Great Rivers Greenway (GRG)

GRG is a public agency created by public vote in 2000 to fund parks and greenways.

GRG is governed by a 12-member Board of Directors and led by a staff of 40. There are more than 135 miles of greenways and counting!

Greenways are paved trails where people can walk, run, bike, use a wheelchair or push a stroller.



Right now, the Maline Greenway is in Bella Fontaine Park (pictured). This project will extend the Maline Greenway from Bella Fontaine Park to West Florissant Avenue.

How are greenway locations chosen?

GRG's goal is to connect three areas (St. Louis City, St. Louis County and St. Charles County) with a 600-mile network of greenways. Greenway locations are chosen through planning processes that consider connections to community amenities, physical conditions, and public input, among others.

How do I participate?

Come to pop-up events, take surveys, attend neighborhood meetings, and/or join the Community Advisory Committee!
