



**FERGUSON CITY COUNCIL**

**Special Council Meeting Minutes  
November 7, 2006**

The regular meeting of the Ferguson City Council was called to order at 6:00 p.m. on November 7, 2006 by Mayor Brian P. Fletcher, in the Council Chamber of City Hall, 110 Church Street, Ferguson, Missouri. Mayor Fletcher opened the meeting and requested a roll call. On roll call, the following Council members were present:

Also present were City Attorney Stephanie Karr, and Deputy City Clerk Sonya Brooks. Ms. Brooks declared a quorum was present.

Mayor Fletcher welcomed all present and explained the Council would be having a special presentation from East-West Gateway to discuss the upcoming City Manager search.

**BUSINESS - SPECIAL PRESENTATION**

Julianne Stone, Director of Local Government Partnership, East-West Gateway discussed the following:

- 1) Proposed contract – Council was in agreement with details of the contract.
- 2) Potential Timeline – the Council will aim to maintain the timeline proposed. The Council understands the schedule may be extended due to scheduling conflicts during the interviewing process.

3) Discussion Questions – the Council will review the questions and be prepared to address them at the next meeting scheduled in December.

4) Draft Job Announcement – the following suggestions were made:

- Add Master's preferred
- Emphasize diverse community
- Candidate to have success with redevelopment agreements
- Include the new NorthPark development
- Reports to "seven-member" city council
- Residency required to remain
- Salary range: \$90,000-\$110,000
- Application deadline: December 22, 2006

A final draft will be provided by East-West Gateway.

Council requested that East-West Gateway have a second tier of candidates in case a successful candidate is not found in the first tier selected.

Next meeting scheduled for Saturday, December 2, 2006 at 9 a.m. The meeting will be to review the discussion questions and to begin a draft of the City Manager contract.

There being no further business to consider, Council Member Knowles moved to adjourn, seconded by Council Member Corson. The meeting adjourned at 7:30 p.m.
