


## **FERGUSON CITY COUNCIL**

**Special Council Meeting  
November 29, 2005**

**COUNCIL MEETING, 7:00 P.M.**

A special meeting of the Ferguson City Council was called to order at 7:00 p.m. on November 29, 2005 by Mayor Brian P. Fletcher, in the Council Chamber of City Hall, 110 Church Street, Ferguson, Missouri. Mayor Fletcher requested that everyone stand for a moment of silent prayer, after which the Pledge of Allegiance was recited. On roll call, the following Council members were present:

Also present were City Manager A.J. Krieger, and City Clerk Debbie Matthies. Mrs. Matthies declared a quorum was present.

Mayor Fletcher welcomed all present and explained the Public Portion and the Business Portion.

### **PUBLIC COMMENTS**

John Knowles – 716 N. Elizabeth – announced his candidacy for the School Board for Ferguson Florissant School District in the upcoming April 2006 election.

Joe Lonero - thanked Council for the special meeting in addressing the liquor license and Bill No. 6729 for the financial assistance agreement with El Palenque Restaurant. Owner Maria Flores was present and discussed the business and hours of operation.

OT Hodge Chile Parlor - Joe Schaumberger was present and asked if Council would reconsider financial assistance for OT Hodge Chile Parlor and discussed the liquor license and hours of operation.

Mayor requested additional information from staff regarding the possibility of financial assistance for OT Hodge Chile Parlor.

**BILLS REQUIRING SECOND READING**

BILL NO. 6729 - AN ORDINANCE AUTHORIZING THE EXECUTION OF A FINANCIAL ASSISTANCE AGREEMENT, PROMISSORY NOTE AND SECURITY AGREEMENT WITH MARIA FLORES D/B/A EL PALENQUE RESTAURANT REGARDING THE IMPROVEMENT AND OPERATION OF A NEW RESTAURANT WITHIN A REDEVELOPMENT AREA WITHIN THE CITY. Introduced by Council as a whole and read the first time.

City Manager, A.J. Krieger explained that El Palenque owner, Maria Flores is going through a process with UMB Bank to pursue the loan, which is separate from the grant.

A motion to read the Bill a second time and place it upon its passage was made by Council Member Corson, seconded. On roll call vote the motion carried as follows:
